School Parent and Family Engagement Policy

MATAGORDA ISD SCHOOLS 2022-2024

Matagorda ISD agree to implement the following requirements as outlined by ESSA Section 1116:

A. ANNUAL TITLE I MEETING

<u>Matagorda ISD</u> will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parental involvement policy, the school-wide plan, and the school-parent compact.

On May 9, 2022, Matagorda School held its Annual Title I meeting to inform parents of the requirements of Title I and the school's participation as well as the parents' rights to be involved. The meeting allowed parents to review the policy and suggest changes to the policy Time 2:00-3:00 pm

On May 11, 2022, Matagorda ISD Board of Trustees were presented with the Annual Title Program report. The report was approved with a 5-0 vote Time 6:00-6:43pm

On August 16, 2022, Matagorda School held its Annual Title I meeting to inform parents of the requirements of Title I, get input from parents concerning Title I through surveys, and to answer questions. Parents were given a copy of the Parent Compact. Time 6:00 – 7:30 pm

On January 11, 2023 Matagorda ISD Board of Trustees approved the updated Parent and Family Engagement Policy with a 6-0 Vote. Time 6:00 pm

B. FLEXIBLE NUMBER OF MEETINGS

<u>Matagorda ISD</u> will offer a flexible number of engagement meetings at convenient times for families, such as meetings in the morning or evening (for which the school may use Title I funds to provide transportation, child care or home visits, as such services relate to parental involvement).

C. JOINTLY DEVELOPED

<u>Matagorda ISD</u> will take the following actions to involve parents in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the school-wide program plan.

At the beginning of each school year, we will meet with parents and other stakeholders. During this meeting, parents will receive information about the school's <u>Parent and Family Engagement Plan and the Parent Compact</u> through which parents will be informed of their parental right to be involved in the planning and development of the plan through meetings, surveys and questionnaires. If the program plan is not satisfactory to parents, they may submit comments on the plan to the school administrator or on the provided surveys. The Parent and Family Engagement Policy and Parent Compact will be sent home twice during the school year and made available on the school website. The plan and policy are a discussed with parents during parent-teacher conferences at the beginning of the school year. The policy will be assessed each year based on the number of participants, the number of volunteers, and the responses to the parent questionnaires and/or surveys.

Parents will be involved in planning, reviewing and improving the policy through a yearly review. All parents will have the opportunity to participate in this review.

E. SCHOOL-PARENT COMPACT

Matagorda ISD will take the following actions to jointly develop with parents of participating children a school-parent compact that outlines how families, school, staff, and students will share the responsibility for improved student academic achievement and develop a partnership to help children achieve the state's high standard and how the plan is used, reviewed, and updated.

Matagorda will hold an annual parent meeting to review and discuss any needed changes to the jointly developed school <u>compact</u>. Matagorda will offer parent workshops on an as needed basis. We will also continue to encourage parents to use online resources such as Khan Academy, Edgeunity, and Parent Portal. We have also other reading material to assist parents in supporting their child's academic success.

G. ACCESSIBILITY

<u>Parent Volunteers</u> will be asked to work within the community to garner support for events such as Field Day, parent conferences, field trips, athletic programs, and various other parent events. Parent workshops will be held as needed (interpreters will be available to assist with non-English speaking parents and/or parents with disabilities) to encourage parental involvement in academia. Family and community persons will be made aware of the training sessions through resources such as newsletters, use of the school sign, social media, and the school website.
